FY19 HUD CoC Project Ranking: Budget Amounts

Notes on the FY19 HUD CoC Project Ranking and Budgets:

- Tier 1 represents 94% of the Annual Renewal Demand (ARD). Tier 2 holds the remaining 6% of the ARD and the DV Bonus project for the BoS CoC. The ARD for FY19 is \$9,015,642 (94% = \$8,474,706 for Tier 1).
- The Human Development Commission project straddles Tiers 1 and 2. The funding amounts listed for this project list the amount covered by Tier 1 and the amount of funding that falls into Tier 2.
- One project voluntarily reallocated a portion of its project budget for FY19, totaling \$846,648. This project is a PSH Dedicated Plus project. Two New projects were submitted through these reallocated funds, as well as five Expansions.
- DV Bonus funds are available in the FY19 HUD CoC Competition, as well as traditional Bonus funds. No traditional Bonus applications were submitted during the local application process.
