 <u>HARAs, LPBs, and Funding by Jesica Mays: Funding Changes, Prioritization, LPBs and HARAs.</u> 25 minute powerpoint discussion for HARAs and LPBs to understand how to utilize the decreased amount of funding post-pandemic. Discussion covers Prioritization, understanding limits and requirements of HARA funding, the Coordinated Entry process and how to support HARAs and the CE process.

**By Name Lists and the BNL Report: Jayce Ashwill and Jesica Mays:** Discussion on the BNL referral process and how it works. Having a clear consistent process removes biases and keeps the focus on housing those with the highest priority. Anyone with a permanent housing resource, RRH, VA, shelter, outreach, or agency that receives HUD funding for beds should be involved in the process.
