Housing Choice Vouchers (Christine Miller and Deidre Butterworth- MSHDA). County Wait lists open March 22- April 5, 2023. Currently 28,000 families are in the program.

10% budget increase this year: 1500 vouchers available to fill and 13 housing agents were allocated vacancies across the state. Applications accepted online; reasonable accommodation call: (517) 241-8946. Preferences to Homeless, Disabled, County.

Emergency Housing Vouchers (EHV) have alternate requirements with relaxed criteria. Special Purpose Vouchers: Veterans Administration Supportive Housing (VASH), Moving Up: Transitioning out of PSH, Michigan Dept. of Corrections Initiative and Family Unification Program. https://www.michigan.gov/mshda/rental/welcomelandlords/housing-choice-voucher-landlords
